In this registration package you will find a registration form, information about recording permission for digital data exchange via MijnMitz.nl and the practical brochure.

You **fill in the registration form** and hand it in to our assistant at the counter. She will also ask you for a valid ID, which is why every adult will have to register in person.

After the registration is complete you will receive an e-mail to activate the app 'Medgemak'. This is our secure online platform. You can log in with you DigID details. Here you can make non-urgent appointments, ask short questions, and receive test results. The app can be set to English.

An initial interview does not take place as standard because we have too many registrations. If you would like to have an initial interview yourself, you can do so in consultation with the assistant. If you have an extensive medical history, it is advisable to arrange an initial interview when your medical details have been received.

The **practical brochure** will give you information about how we work. With this we try to keep the waiting time on the telephone as short as possible.

Making appointments and home visit request

You can make an appointment and request home visits by calling. Normally you will be booked for the same day if you call before 10 am. **Due to the amount of incoming calls in the morning we kindly request you to keep the conversations short.**

Appointments with the general practitioner are on the first floor, take a seat in the waiting room.

Appointments with the assistant and nurse practitioner are on the ground floor.

You can take a seat in the waiting room.

Medical results and information

For the results of medical tests and information you can call between 11:00-12:30 am or 13.30-17.00 am.

You are supposed to **call us** for medical test results.

To renew a prescription

Call the pharmacy between 9 am and 12 am (phone: 0900-4433222) or by internet:

mijngezondheid.net, de Medgemak app of Service Apotheek app

You can pick up the medication the next day at the pharmacy.

Practice assistants

The assistants run their own consultation hours for: first aid, blood pressure controls, cervical smear, treatment of warts, travellers advice and vaccination.

Appointments with the assistant are on the ground floor.

POH

In the Pionier there is a nurse practitioner (POH) employed. The POH is a certificated nurse, who treats medical target groups (like diabetes, asthma/COPD, high blood pressure, the elderly). The treatment is always under supervision of your general practitioner.

Appointments with the nurse practitioner are on the ground floor.

Please, read this letter carefully

What is Mitz?

Are you receiving medical care? Care providers sometimes want to share your medical data with each other. For example, your GP provides data to your pharmacy. This is only allowed with your consent. For this consent we use Mitz. Through MijnMitz, you decide who is allowed to share what medical data with whom. MijnMitz lists all your consent settings in one place.

MijnMitz does not contain any medical data, only your consent settings for care providers.

You can always adjust your choices. They are valid immediately.

You can view this permission when you log in to MijnMitz with your DiGiD
